





Southern Police Commission Continuation Budget Meeting August 18, 2015

A public continuation meeting of the Southern Police Commission was held on Tuesday, August 18 at the New Freedom Borough Council Chambers, 49 East High Street, New Freedom, and PA 17349.

The meeting was called to order at 7:05 p.m.

Commissioner Buchanan provided members with an overview of the budget for the 2014/2015 year.

## **SOUTHERN SCHOOL DISTRICT**

Patrol time needs to increase. The budget for 2015 is \$62,000; so far we have billed \$22, 197. May reach \$30,000 by the end of 2015.

## **BULLET PROOF VESTS**

Have a five year manufacturer warranty. Commissioner Buchanan has a current list. 2015—need to replace one 2016---will need to replace 3

#### **E-CITATION**

Currently have spent \$6500 to install and purchase for seven patrol cars. This will be time saving.

## **CAMERAS**

Currently in 2015 budget Commissioner Buchanan recommended to proceed with purchase.

There was a motion by Commissioner Terrell to table to after arbitration on 8/26/2015. Commissioner Merrick also suggested tabling this until there is an increase in patrol at Southern School District and less overtime.

The motion was to financially withhold until patrol time increased at Southern School District and overtime decreases, by Brady Terrell and second by Roy Burkins.

#### **OVERTIME**

Better management. Currently it is by seniority...which are at a higher pay scale.

Discussion held by commissioners to develop a new policy regarding overtime.

### MEDICAL/DENTAL INSURANCE

Will receive a health rebate this year...but cannot budget this because not necessarily would receive this same amount each year. (it is based on overall use of insurance)

Medical/Vision/Script \$210,329

Employees contribution \$5200 (1 percent)

#### **VEHICHLES**

Currently there are 11 vehicles.

Commissioner Buchanan suggested buy one new vehicle and eliminate two for 2015 and purchase one in 2016 and eliminate more vehicles putting the fleet at nine.

Discussion was held on how many vehicles are needed/officers on duty, how many other police departments currently have. Commissioner Terrell suggested getting rid of two vehicles and not replacing them.

Cost for a new vehicle with all the added lights, cage, decals, etc. approximately \$32,000.

Discussion will continue in September.

#### **SALARY**

Salary is 58 percent of the total budget.

Office Clerk 22 to 24 hours

## **SUPPLIES**

Two percent increase for office supplies, cleaning and cleaning services.

Crystal Clean---\$2973, budgeted \$5576

#### **VEHICLE FUEL**

Budget \$42,649-45,000, down to \$33,000 to 35,000. Suggested to put the \$12,000 back into the reserve.

#### **LEGAL FEES**

## IT (THIRD ELEMENT)

Budget \$20000, spent \$10,525.

#### RENT

Will be increasing by \$15.00 not \$100.00

## **CAPITAL EQUIPMENT**

Continuing to work with Chief

Should have figures in September
