#### **FINANCE & BUDGET**

- R. Herzberger reviewed a revised proposal for three new designated reserve accounts to be established
  on the balance sheet in additional to the two already existing reserve accounts. The revised proposal
  was circulated via email prior to tonight's meeting.
- The two existing reserve accounts are Designated (Donations) and Undesignated (General).
- The finance committee recommends adding three new designated reserve accounts: Compensated Absences, Future Capital Expenditures and Legal/Arbitration, as outlined in the revised proposal.
- R. Herzberger moved to adopt the recommendations of the finance committee to establish the new designated reserve accounts, second by M. Sharkey, motion carried.

### INTERGOVERNMENTAL AGREEMENT COMMITTEE

- M. Sharkey reported that the committee met in February and reviewed their topics of discussion.
- Identified 18 codes relating to police activity specific to member municipalities using four years of raw data.
- Reviewed the 5 main goals of the IGA committee:
  - 1. Commitment to terms
  - 2. Define PPU / PPU minimum requirements
  - 3. Discuss major / minor amendments
  - 4. Define long term obligations
  - 5. Preservation of partnership for the 4 member municipalities
